- The remaining amount will be held in an account for future worker obligations. When the remaining worker obligations are fulfilled, then a refund check will be issued to the said family. If the check is met by insufficient funds, swimmers will not be allowed to swim until the check is made good and all bank fees are covered by the said family.
- If you know ahead of time you are unable to meet your worker obligations required for a meet, please contact the meet directors ASAP. The more notice we have the better we can plan ahead to make the meets successful.
