- Eligibility:** USA swimmers must have current USA or YMCA registration. USA and Wisconsin Swimming rules mandate that substantial fines will be levied against clubs and parents/guardians who enter ineligible swimmers.
USA Swimming deck registration will not be accepted.
- Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- Class of Meet:** This meet will include a single session Friday evening and two sessions for Saturday and for Sunday for all age groups.
- Facility:** Indoor, 50-meter pool with 8 lanes, Pool depth 7' at the shallow end and 16' at the deep end. Starting blocks are 29.5". The Competition course has been certified in accordance with 104.2.2C (4).
- Timing System:** A fully automatic Colorado timing system with 2 manual back-up buttons and two back-up timers for each lane will be used. If the automatic system fails, a gun or horn start will be used.

- Entry Deadline:** Team entries via emailed entry file, hard copy, waiver, and fees must be received by the Entry Chair **no later than 6:00 PM, May 19, 2015. Submit entries times as LCM. Please do not submit more entries than you have reserved unless you have checked with the Meet Director.**
- Entry Fees:** \$5.00 per individual event, \$3.00 WI LSC Splash Fee, and \$6.00 Facility Usage Fee for each swimmer entered in the meet. All fees must accompany entries. Checks are payable to "SEA".
NOTE: Please be sure the waiver is signed. We cannot accept entries without a waiver.
- Entry Limits:** Three (3) events per day.
- Disabled Swimmers:** Coaches are responsible for informing Officials and the Meet Director of any disabled swimmer's needs prior to warm-ups.
- Deck Entries:** Deck entries will be accepted to fill open lanes. No additional heats will be added. \$8.00 per individual event--plus \$3.00 WI LSC Splash Fee and \$6.00 Facility Usage Fee if the swimmer is not already entered in the meet. Deck entries will close 30 minutes prior to the beginning of each session.

- Meet Format:** This is a timed final meet with positive check-in (for all events in the meet except the first girls' event of each session). Coaches will be issued a positive check-in sheet for each session of the meet. Check-in sheets must be returned to the office no later than 45 minutes prior to the beginning of each session. Meet management reserves the right to limit entries/heats to meet the session time limit. Flyover starts will be used. **Multi-age event format will be used. The Hy-Tek event file for Senior events will be 15 and over. However, a swimmer of any age may participate in a Senior event. Please "age-up" a swimmer younger than 15 who wants to compete in a Senior event.**
- General Rules:** Official 2015 USA and Wisconsin Rules shall prevail for this meet. Age as of May 29, 2015. Coaches must display their current coaches' card while on deck. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- Coaches Packet:** Coaches may pick up their packets from the office. Any monies owed must be paid before you can obtain your packet. Please be prepared to show your coach's card at the time you pick up your team packet. Coach's cards must be visible at all times on deck.
- Scoring:** 16 place scoring will be used:

- Admissions:** \$5 per day for spectators ages 12-and-up—cash only.
- Heat Sheets:** Will be posted on our website prior to the start of each session. A limited number of heat sheets will be for sale at the meet for \$5.00.
- Food:** A selection of food items will be available during the meet at the concession stand. Coaches will be served free of charge by showing their current coaching credentials.
- Lost and Found:** Will be housed outside the office during the meet. Items remaining in lost & found at the conclusion of the meet will be donated to the Salvation Army.
- Conduct:** Coaches are responsible for the conduct of their athletes and will see their team has proper supervision at all times. Please ensure swimmers clean up after themselves so that your team area is clean prior to departing the meet. In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is prohibited. Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.
