## Approval of agenda and minutes

### Head Coach

- 1. YMCA Discussion
- a. What does a fully YMCA swim team look like?
  - i. Paying a FULL youth fee for YMCA.
  - ii. Registration-SEA would still have registration night at the pool. Can also be done at YMCA desk.
  - iii. Would we still have/need a parent board for SEA? Yes, it would be an advisory board for the YMCA. Possibly have a few SEA board members at corporate board. Ahmad will send a description of current YMCA advisory board positions.

- iv. Swim team will need to send budget to YMCA and SEA would need to meet budget.
- v. Team would have a custodial account.
- vi. SEA would still need to fundraise in order to meet budget.
- vii. YMCA CFO will handle the payments for meets and inform team of amounts due for escrow accounts.
- viii. Team members will still need YMCA membership and USA swimming membership.
- ix. If we do not become a fully Y team SEA will no longer have access to YMCA pools for practices. Also, we will lose Y Nationals, Y sectionals, Y state, and Y regionals.
- x. Missy Reischl and Neil Wright will put together a list of Pros/Cons to present at May parent board meeting.
- PPP (Paycheck Protection Plan)
  - i. The YMCA received money that will allow them to pay salaried SEA coaching staff for the next 8 weeks.

#### 3. Coaches

- i. Neil presented to the board what he has been doing with Senior level swimmers to date.
- ii. Katie presented to the board what she has been doing with the Gold level swimmers to date.
- iii. Board voted on coaches having a team dryland via Zoom meetings.
  - a. Would begin on Monday, May 4, 2020 on Mondays, Wednesdays, and Fridays and be 60 minutes long.
  - b. Cost will be \$100 for May. Payment will be mailed in or possibly online payment.
  - c. Re-evaluate dryland in two weeks to decide changing to socially distanced face to face.
